

SCICON Cabin Counselor Job Description

Description of Duties:

Under the direction of the SCICON staff, supervise 10-12 sixth grade students both in the cabin, on the trail, in the dining lodge, and at various evening activities. Implement appropriate cabin activities, alert SCICON staff to potential problems or unsafe situations. Participate fully in all SCICON activities as a positive role model. Uphold the SCICON rules and disciplinary policy. Assist and support all SCICON staff and classroom teachers.

Minimum Qualifications:

Currently enrolled as a junior or senior in high school. Must be in good academic standing with no disciplinary record. Must be a good role model. Must be able to accompany students on rough trails and steep inclines with irregular and slippery surfaces.

Skills Required:

High energy level. Positive and cooperative attitude. Willingness to learn and work with others. Good communication skills.

I agree to never post or publish, on the internet, pictures, video or any information about students, teachers or staff at SCICON. _____

I agree to refrain from any dress, speech, or actions which could be construed as "gang-related." I agree to alter my dress or appearance should it prove to be offensive or have negative implications in working with the children. _____

I agree to not discuss, nor answer questions, about my personal life. I also agree not to share or discuss personal information such as phone numbers, email addresses, websites, etc. _____

I agree that while at SCICON I will not bring or use tobacco products, alcohol, or illegal drugs. _____

I understand for my protection, I should not touch children. _____

If I have any difficulties, I agree to ask the SCICON staff to help me. _____

I agree to never post or publish, on the internet, pictures, video or any information about students, teachers or staff at SCICON. _____

I understand that any infraction of the above statements can result in my immediate dismissal. _____
